National Housing Strategy

November 22, 2017 – Federal government housing strategy establishes a minimum target for new housing for individuals with DD



National Housing Co-Investment Fund Outcomes



Applications for the National Housing Co-Investment Fund will be accepted starting April 1, 2018.

Background To ICC



 Housing – a fundamental pillar for persons with developmental disabilities

 "One size does not fit all" – wide range of needs, wide range of options

The Issue



Persons with developmental disabilities have;

- Amongst lowest incomes of any segment
- the longest housing wait times
- are systematically/ systemically discriminated

against in the market

• Want a place to call home

Other Issues



- MCSS is not a housing ministry
- Ministry of Housing, no plan, data or link to DD
- National Housing efforts have never targeted or identified the DS sector as a vulnerable population
- CMHC and other housing funders require operational guarantees
- Can't do this alone, or on one off basis

The Financial Challenge



- Low income , requiring costly design adaptations, "bricks and mortar" options require both upfront capital and ongoing operating support
- Private sources such as families, community and corporate donors, lenders usually insufficient to fully meet financial requirements
- Meeting requirements requires additional financial input from government complex process

Agency Challenge



- Agencies providing housing for persons with DD need to plan and find stable housing that :
 - Meets the needs of individuals
 - Is affordable \$479 a month
 - Too build they need
 - Sources of funds capital
 - Technical aspects of housing design/development
 - Political good will

Current Programs



- Currently a number of programs available providing capital funding to help develop housing for persons with developmental disabilities:
 - Investment in Affordable Housing (IAH) Program
 - Home for Good Program
 - Municipal Incentives (eg. Toronto Mayor's Open Door Program)
 - Portable Housing Allowances
 - CMHC SEED Program
 - CMHC Rental Housing Construction Loan

Positive Change is Coming



 Opportunity to leverage other Federal Government budget commitment to invest \$11 billion in housing nationally over next 10 years

- Additional housing dollars also remaining in system after end of Operating
- Agreements

What Do Agencies Need To Do



- Be prepared funding usually goes to those best prepared to move forward
- Understand needs, identify preferred solution, determine required costs and resources, develop financial strategy, prepare plan
- Identify relevant funding programs, learn requirements, aim to meet requirements as fully as possible

Members of the ICC are expected to:

- Participate actively in expanding the supply of accessible supportive housing in Ontario,

- Advocate to government and other funders for funding and program support,
- Contribute 10 hours or more per month in support of the common effort

The Ask



- 5% Affordable Housing to Developmental Disability Housing – Got minimum 2,400 units
- Funds to build multi unit Community Residence - funding 2/3 government, 1/3 public/agency – asking for \$66 million over 5 years

Co-Housing Projects



- 20 Unit Self Sufficient Housing project
- Mixture of 1,2,3 bedrooms potentially supporting 52 persons; Staff, Families and Persons Supported
- Less than one third of total housed will be persons wo have a disability
- Persons supported will likely be housed in units of 1,2 bedrooms
- All units will be accessible
- Units will be of Modular construction
- Units will be under CCO control as a Life-Lease*
